Meeting Minutes

Mammoth Lakes Tourism & Recreation Conference Room 2520 Main Street, Mammoth Lakes, CA

ROLL CALL

The meeting was called to order at 3pm with the following Committee Members in attendance: Alan Jacoby, Danna Stroud and Grady Dutton as the representative for the Town.

PUBLIC COMMENT (On items not on the Agenda)

• There were no public comments.

ADMINISTRATIVE ITEMS

- 1. Approval of the Agenda
 - The agenda was approved as published.
- 2. Approval of the meeting minutes for 10/14/15
 - The minutes were approved as submitted. (Motion by Grady, Second by Alan, 3-0)
- 3. SHARP Trail Alignment Studies
 - The trails coordinator provided a brief report to include the following items:
 - i. A draft request with a focus on trail #18 is being crafted to be shared with MTC
 - ii. There was a request to perhaps include this trail request with the other six that are being proposed to the USFS.
- 4. LABBS Alignment Studies
 - The trails coordinator provided a brief report on the process in which he is working with the Town Manager to submit a request to the NFS outlining the proposed work to be completed.
 - There is a need to reconvene the TCC to finalize the recommendation.
 - There have been 5 bids for the Pokonobe to the Lake Mary dam MUP the Town Council will review a recommendation for this work at their 12.16.15 Council meeting.
 - There were expressed safety concerns about this MUP ending by the stop sign on the other side of the dam and the need to work with Tamarack as we build infrastructure
 - This work is being completed in two phases due to funding but should be viewed as one project so that they are coordinated
 - There was a request to provide more information to the committee regarding this process at the next scheduled Trails Meeting scheduled for 12.09.15.
- 5. "Soft Surface Trails USFS Permitting"
 - The trails coordinator provided a brief update on the project and reminded the committee that this should include both maintenance and new construction.
 - There appears to be a Challenge Cost Share Agreement in place between the USFS and the Town through 2018 which may be an element of a CCSA "Supplemental Partnership Agreement" that was executed in 2013. Joel to follow up and report back to the MTC.
 - The trails coordinator posted and reviewed the proposed trails maintenance along with reviewing the proposed re-allocation of funds to support the 2016 maintenance program.

- Alan made a motion to approve the re-allocation of \$80,000 for 2016 trails maintenance. A second to this motion was provided by Grady and the motion passed 3-0.
- 6. MLTS Winter Programs Update
 - The trails coordinator provided a brief report on the these items to include the following:
 - Sherwins Winter Access
 - i. The USFS is concerned about access through Tamarack Road because there is no parking
 - Shady Rest
 - i. The USFS is has approved CCSA SPA that will allow the Town to engage with the FOI for contract services.
 - ii. There as a request that the FOI share their marketing strategy and materials at the next MTC meeting on 12.09.15.
 - iii. There were unanswered questions about signage.
 - MLTS Website Content Development
 - i. Nicole Montano provided the committee with a brief update and the request to schedule a winter content meeting in the near future. There is a need for winter photography with an expected transition of 12.01.15.
 - USFS/TOML Leadership Meeting Agenda Items
 - i. The trails coordinator indicated that these items are slated to be discussed at the yet to be schedule leadership team meeting.
 - ii. INF OSV NEPA Review Matching Funds
 - 1. Progress report is requested on this item.
 - iii. SR 203 Tunnel OSV Access to Shady Rest RV Park
 - 1. Progress report is requested on this item.
 - iv. Shady Rest Winter Grooming
 - 1. Already discussed above.
 - v. USFS Rep for MLTS Web
 - 1. It appears that Lawson Reif is the USFS rep \odot
- 7. MLTS Website Update
 - The trails coordinator reported that the transition is in process as described in the above mentioned content development with MLT being a very strong and supportive partner.
- 8. Summer of Stewardship Program Report Out
 - Casey and Jay representing the FOI provided a very extensive summary of the completed work that was accomplished this past summer.
 - There was a request to share the power point presentation with the MLR staff that could be posted on the MLR web site.
- 9. Lakes Basin Stewards Report Out
 - Casey and Jay representing the FOI provided an update of their work in the Lakes Basin which included an overall distance of 493 miles of covered trails.
 - There were questions about how do the FOI identify priority projects which led to the conversation about having a closer working relationship with the USFS in the past when they had more staff.

 - There was no report on this agenda item. Was rescheduled.


